ORDER :

Through the reference 1st read above, the Additional Director, CPA India Branch, New Delhi has informed that the CPA Head Quarters, London is conducting the Commonwealth Women Parliamentarian Triennial Conference in connection with the 62nd Commonwealth Parliamentary Conference in London, U.K from 11th to 17th December, 2016 and stated that the CPA Secretariat, London has allotted six places for the CPA India Region and the CPA branches may nominate one lady Legislator to the said conference. Accordingly the Hon'ble Speaker has nominated Smt.V.Anitha, MLA for participating in the Commonwealth Women Parliamentarian Triennial Conference held at London and the same has been intimated to the CPA Head Quarters, London and also to Smt.V. Anitha, MLA.

2. Through the reference 2nd read above Smt. V. Anitha, MLA has certified that an amount of Rs.1,85,910/- incurred by her towards airfare and visa charges etc., for to and fro journeys i.e.s., Hyderabad – London – Delhi – Hyderabad for attending the 62nd CPC in London, UK from 11th to 17th December, 2016 and D.A for 6 days, @USD 75 per day i.e.s 6 X 75 = 450 USD converted into Indian Rupees @65/- i.e.s., 450 USD X 65/- = Rs.29,250/-, thus total amount of Rs.2,15,160/- (Airfare Rs.1,85,910/-+D.A Rs.29,250/- =Rs.2,15,160/-) has to be settled by this Secretariat.

3. Accordingly the Government after careful consideration, hereby sanction an amount of Rs. 2,15,160/- (Rupees two lakhs fifteen thousand one hundred and sixty only) to Smt.V. Anitha, MLA, A.P.Legislative Assembly as an amount to perform to and fro journeys to attend the 62nd CPC Programme held at London from 11th to 17th December, 2016 in relaxation of relevant rules and Treasury Control Orders etc.

4. The expenditure sanctioned above shall be debited to "MH 2011- State Legislature; 02- State Legislature; 101- Legislative Assembly; S.H. (05)- Members; 110- Domestic Travel Expenses; 111- Traveling Allowances" in relaxation of rules and met from out of the existing budgetary provision of Legislature Secretariat during current financial year 2017-2018 and in relaxation of Quarterly regulation and treasury control orders.

5. The amount sanctioned at para (3) above shall be drawn and credited A/c No.52208811043, SBH, Secretariat Branch, IFSC Code: SBHY 0020077 of Smt. V. Anitha, MLA, A.P.Legislative Assembly while submitted detailed bill within a stipulated time.


