ORDER:

Legislative Assembly to discuss the problems being faced by Telugu people in Kuwait from 27th to 30th May, 2015 and for meeting the expenditure of ₹ 93,800/- (Rupees ninety three thousand eight hundred only) towards actual to and fro Airfare from Hyderabad - Abudabi - Kuwait - Mumbai - Hyderabad.

The expenditure sanctioned in para 2 above shall be debitable to "2011-State Legislature; 02 - State Legislature; M.H 101- Legislative Assembly; S.H (04) -Speaker and Deputy Speaker (Charged); 120 - Foreign Travel Expenses; 121-Foreign Travel Expenses" and met from out of the existing budgetary provision of Legislature Secretariat during current financial year 2015-2016 in relaxation of Quarterly regulation and treasury control orders.

4. The amount sanctioned in para (2) above shall be drawn in favour of Dr.Kodela Siva Prasada Rao, Hon'ble Speaker on presentation of the detailed tour bill.


