Satyanarayana Rao, Secretary, Legislature (I/C) as a SCOATT Member of CPA UK Branch is also attending the said Conference along with the Hon'ble Speaker, Andhra Pradesh Legislative Assembly and also visiting Mauritius, South Africa and Nairobi, Kenya as desired by the Hon'ble Speaker vide reference 2nd Cited.

2) Through the reference 2nd read above, the Ministry of External Affairs (Coordination Division) has issued No Objection from Political Angle for the visit of Sri K. Satyanarayana Rao, Secretary, Legislature (I/C) to Cameroon.

3) Through the note 3rd read above, M/s. Venki Travels has forwarded an invoice for ₹ 4,75,564/- towards the estimated airfare for the sectors Hyderabad – Mauritius – South Africa – Cameroon – Nairobi, Kenya and back to Hyderabad from 27th September to 11th October, 2014 for the official foreign tour of Sri K. Satyanarayana Rao, Secretary, Legislature (I/C) has to be sanctioned to the Secretary.


