



No. 322/AP-LC/2019 (MLAs) (2): - WHEREAS, the Governor of the State of Andhra Pradesh has, by notification issued under section 16 of the Representation of the People Act, 1951 (43 of 1951) and published in the official Gazette of the State on 21st February, 2019, been pleased to call upon the members of the Legislative Assembly of the State, to elect 5 (Five) members to the Legislative Council of the State: -

Now, therefore, in pursuance of sub-section (1) of section 39 and section 56 of the said Act, the Election Commission of India hereby -

(A) appoints, with respect to the said election -

- (a) the 28th February, 2019 (Thursday), as the last date for making nominations;
- (b) the 1st March, 2019 (Friday), as the date for the scrutiny of the nominations;
- (c) the 5th March, 2019 (Tuesday), as the last date for the withdrawal of candidatures;
- (d) the 12th March, 2019 (Tuesday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 15th March, 2019 (Friday), as the date before which the election shall be completed; and

(B) fixes the hours from 9:00 a.m. to 4:00 p.m., as the hours during which the poll shall, if necessary, be taken in all the above mentioned States, on the date specified above, for the election.
